

Red Tape Challenge | Background and Context

- "Red Tape Challenge" announced by SofS and NHS CEO October 2024
- Reduce bureaucracy through a rapid review of issues and tangible solutions
- Broad scope primary, secondary, community and mental health, for patients
 of all ages
- Led by Claire Fuller and Stella Vig
- Short-term, operational improvements (however radical) for immediate impact
- Longer-term, strategic and transformational changes identified <u>will be fed into</u> <u>10 year plan</u>
- Reporting early in the new year, linked to Operational Planning Guidance, Elective Recovery Plan and other key documents

Red Tape Challenge | Engagement approach

- Engaging wide range of stakeholders, in collaboration with NHS Confederation:
 - Phase One Listening (till mid-December)
 - Phase Two Testing emerging recommendations (December/January)
- Multi-faceted approach of surveys; case studies; presenting to existing forums and bespoke sessions, underpinned by a literature review.
- 5 enabler working groups to cover: referrals (inc. Advice & Guidance); transfers of care (inc. informal follow ups) and communications (between staff and with patients) across all stakeholder groups:
 - Medicines & Prescribing
 - Data, Digital and Technology
 - Workforce, Training and Education
 - Contractual and financial flows
 - Metrics
- Continue to identify and promote best practice but also looking to reduce variation in areas doing less well through clearer accountability, levers and measurable impact
- Ensuring bottom-up suggestions that ICBs and providers can see the benefits of implementing (no additional funding) framed around short-term actions owned at national, system and provider level


Primary-Secondary – Autumn Assessment

- Assessment form updated to reflect feedback, including taking account of digital challenges around implementing electronic fit notes in 24/25 received positively. Free text boxes reduced from five to one at the end for ease of completion (and analysis)
- As before, ICBs validated trusts' self-assessments, and NHSE Regional teams analysed the free text
- Improvement across all key areas, except due to clarification of wording in the form
- Response rate of 96%— improved from 92% in April and includes returns from acute trusts completed for either or both April and September – but excludes all known MH and community trusts




Results – progression from April to September



Interface results by region – April to September


