Opportunity for Practices to join the NWL Population Risk Segmentation Project

What is the project?

We aim to support practices and PCNs in meeting the Capacity and Access Improvement Plan (CAIP) 2025/26 Risk Stratification requirements, which account for one-third of the total eligible CAIP payment. For a PCN with a population of approximately 50,000 patients, this could represent a value of over £20,000.

We would like to upload Whole Systems Integrated Care Risk Segmentation (WSIC) Data into practice clinical systems (Optum EMIS & TPP). Adult Risk Groups include: Specialist/End of Life (0.7%), High Risk (2.9%), Rising Risk (0.6%), Stable Risk (19%) and Well (77%).

By uploading insights directly into clinical systems we hope this will encourage proactive reviews and in real-time reactive care pathway optimisation. NW London will undertake a qualitative evaluation of Phase 1 pilot sites and look to procure middleware for direct integration for Phase 2. In alignment with the 10 Year Health Plan, this initiative will be a step forward in empowering primary care services with data on digital platforms to shift towards preventive and proactive care.

The Whole Systems Integrated Care (WSIC) system operates under strict safety and governance processes, ensuring secure data sharing, compliance with NHS information governance standards, and robust oversight to protect patient confidentiality and data integrity.

What are the benefits to PCNs/practices?

In addition to supporting practices to achieve financial incentives this year, participating practices will also stand to gain:

- A clinical standard operating procedure for staff reference which serves as a guide only
- You will be asked to approve the allocation of a dedicated NWL Information governance and RA02 Smartcard compliant staff member to upload the data monthly into your clinical system

What do interested PCNs need to do?

We are looking for a spread of practices across NWL for Phase 1a \sim 35 practices to collaborate with. Phase 1b will extend this to all PCNs / practices to participate and be eligible for the Risk Stratification component of the 25/26 CAIP payment
