CSAS News

During June, a total of 451,250 invitations were sent out, a decrease of 16.5% following high volumes since January. Reminders also decreased in month by 10.5% to 347,908, however these remain in line with current year-to-date averages. The number of results has further decreased by 13.6% to 270,163 following yearly trends.

Information / Updates

NHS digital have issued a user guide relating to CSMS which users may find useful. The guide includes information such as:

- How to access CSMS
- How users can check they have the correct access rights
- Different options for patient search
- Different options to defer or cease via CSMS
- Patent summary which includes how to view previous test results, HPV information and details of which GP the patient is registered with
- Notifications (which has replaced PNL's)
- Within the notifications is a "patient to review "section which highlights any new patients requiring follow up, new patients who are ceased & existing patients recently ceased.
- Managing the GP practice email held in CSMS to ensure notifications (previously known as PNL's) are received.

Manual Matching Figures

Below are the manual matching figures from May 2024 for:

- Health Service Laboratories Cervical Cytology Service
- National

'Non hits' are where CSAS need to 'manually match' data that does not directly match the information held on the NHAIS system.

The sample taker is responsible for making sure that the sample and request submitted relate to the correct person. It is essential that the sample taker checks with the individual that:

- their details on the downloaded request form are correct
- their correspondence address is current
- the personal details relate to them and are correct (such as their full name and date of birth)

If the address is not current, advise the call and recall service of the new details as soon as possible. This will prevent downloaded results from laboratories being rejected or correspondence sent to the wrong address.

The sample taker is responsible for making sure that the person is contactable so they can be advised of any further tests or investigations needed following screening.
